FAIRFAX SOFTWARE SECURES IRS WIN

Fairfax Software is pleased to announce that it has been notified by the Internal Revenue Service (IRS) that it was the successful bidder in securing the 1042 Foreign Payment Practice (FPP) Data Integrity Software Pilot Project. The area, which is located within the Large Business & International (LB&I) Division, upholds the enforcement of taxpayer compliance with the IRS Form 1042-S (Foreign Person's US Source Income Subject to Withholding).

The Form 1042-S collects a variety of codes and information to help the IRS determine whether the correct amounts have been withheld under the various laws and treaties applicable to the withholding agent and the foreign person receiving the payment. Through its secure FEDRAMP compliant cloud environment, Fairfax Software offered the IRS a hosted automated solution to help alleviate the burden on the IRS's staff. Through its artificial intelligence capabilities, this solution will guide the foreign withholding agent through the process and will offer them options and corrections, such that the data uploaded will be totally "scrubbed and vetted" by the time it reaches the IRS servers. In classification terms, this means redirecting the IRS personnel work hours from manual, repetitive, non-decisional duties to actions that are more analytical, cognitive, and strategic in nature.

By logging on to the secure Fairfax Software cloud, a withholding agent will be able to transfer their data from a current commercial accounting software system such as Quick Books® Essential, Sage 50cloud®, and Freshbooks® to our Form 1042-S Data Integrity Solution. Additionally, acceptable files include, but are not limited to, Microsoft Word®, Microsoft Excel®, text, or XML formats.

Another attribute of the Fairfax Software Form 1042-S Data Integrity Solution is an automated 1042-S form available for manual utilization by the withholding agent. The withholding agent will not be able to input erroneous data. Instead, once the agent attempts to input the wrong data, a prompt will come up immediately to notify the agent of the error, and instructing them on the required corrective action resulting in pure data.
